**Edoardo Bressanelli** is 'Montalcini' Assistant Professor in Political Science at the Sant'Anna School of Advanced Studies. Before, he has been a Senior Lecturer in European Politics at King's College London, where he is affiliated as a Visiting Senior Research Fellow. He has published in journals like *Comparative Political Studies*, the *European Journal of Political Research*, the *Journal of European Public Policy*, among others. He has been a consultant for the European Parliament on several projects, most recently on 'Institutions and Foreign Interferences'.

**Giuseppe Martinico** is Full Professor of Comparative Public Law at the Sant'Anna School of Advanced Studies. Prior to joining the Sant'Anna School of Advanced Studies he was García Pelayo Fellow at the Centro de Estudios Políticos y Constitucionales (CEPC), Madrid, and Max Weber Fellow at the EUI. His research interests cover both comparative and European law, fields in which he published extensively, including two monographs in English (one with Elgar and one with Routledge). He has published in international peer-reviewed journals in three languages (English, Italian and Spanish).

**David Natali** is Full Professor at Sant'Anna School of Advanced Studies. He holds a PhD in political science from the EUI. The specific focus of his research is the comparative analysis of pensions, the EU coordination of social protection and social inclusion policy, the Lisbon Strategy and the Europe 2020 Strategy. He has been involved in several European integrated projects and networks of excellence financed through the 6th and 7th Framework Programmes (including NEUJOBS, NEWGOV, INTUNE, RECOWE). He coordinated several research projects on pensions and the EU social dimension and the comparative analysis of pension reforms
